PASSENGER EMBARKATION FEES - Children up to 2 years old are exempt from such fees, while children from 2 to 12 years of age pay half of the amount due for adults according to Art. 5, Law n. 324/1976. Passenger embarkation fees vary from EU and extra EU flights.

Passengers on duty traveling as 'Crew must go' or 'Crew returning to base' are also exempt from Embarkation Fees provided they check-in with a valid ticket issued by the airline, proving the right to fly for free due to operational necessities of said airline.

GENERAL AVIATION LANDING AND TAKE OFF FEES - The amount due to the airport managing company is shown in the above table. On the final invoice, however, the amount will be multiplied by two according to Italian Law n. 656/1994 converting Decree-Law n. 564/1994.

PARKING FEES - According to Italian Law n. 324/1976, the amount due is obtained by multiplying the aircraft's weight (in tons) by the parking duration (in hours) exceeding the first two hours which are free of charge.

The 'BUE airside uncovered areas' fee amounts to 50% of the 'BUE airside operational spaces' fee.
